With scientific facts and mathematics to the respect and dignity of the dead during the covid-19 crisis

Abstract

Minister of Health, dr. J. Poklukar, claimed that 300 lives were to be saved during the Vaccination Days. His claim has no scientific basis. Official statistics and mathematical calculation reflect facts that are diametrically opposed. Such public appearances of officials are not decent, not scientific and not ethical. As such, it further tarnishes the entire corona happening, which is saturated with a lack of common sense, scientific accuracy, ethical truthfulness and moral concern for the common good of all people. Mathematical calculations show that covid-19 vaccines are not effective, do not save lives and that covid vaccinations should be stopped immediately, but in no way should it be made mandatory. Z znanstvenimi dejstvi in matematiko do spoštovanja in dostojanstva umrlih med kovidno krizo

Povzetek

Minister za zdravje, dr. J. Poklukar, je zatrdil, da naj bi med Dnevi cepljenja rešili 300 življenj. Njegova trditev nima znanstvene podlage. Uradna statistika in matematični izračun odražata dejstva, ki so diametralno nasprotna. Takšno javno nastopanje funkcionarjev ni dostojno, ni znanstveno in ni etično. Kot takšno dodatno omadežuje celotno koronsko dogajanje, ki je prenasičeno s pomanjkanjem zdravega razume, znanstvene točnosti, etične resnicoljubnosti in moralne skrbi za obči blagor vseh ljudi. Matematični izračun pokaže, da kovidna cepiva niso učinkovita, da ne rešujejo življenj in da bi bilo treba cepljenja za kovid nemudoma ustaviti, nikakor pa se ga ne bi smelo uzakoniti kot obveznega. Ključne besede: znanost, koronska kriza, kovid-19, kovidno cepljenje, število umrlih.

1. INTRODUCTION

Recently, we read in the Slovenian media the news about the categorical statement of Minister of Health, Dr. Janez Poklukar: "In Slovenia, 76,544 vaccinations against Covid-19 were carried out during the vaccination days, Health Minister Janez Poklukar said today. He estimated that the campaign prevented about 2,000 hospitalizations, 500 admissions to intensive care units and 300 deaths. He also thanked all citizens for their response and help in fighting the Covid-19 epidemic" (STA, 2021).

If 76,544 people were supposedly 'saved' by vaccination for Covid's death, then out of one million vaccinated, 3,919 people were 'saved' from the trash. According to official SURS (Statistical Office of the Republic of Slovenia) data, 17,680 people died in Slovenia in the first 10 months of 2020, when vaccination against Covid-19 had not yet been carried out. In the same period of 2021, 18,434 people died, which is 754 more people than in the same period of 2020 (STAT.SI, 2021).

Facts in numbers

If vaccination of 76,544 people saved 300 lives, then vaccination of one million people would save the lives of 3,919 people. According to the minister's statement, 3,919 fewer people should die in Slovenia in the first 10 months of 2021 than in the same period of 2020 because the coronary vaccines would really "save lives."

We had Corona and disease Covid-19 in 2020 and 2021. In 2020 there was no vaccine, in 2021 we had it and therefore the mortality rate in 2021 should be lower than in 2020. But in 2021, at the end of the tenth month, there were 754 more people than in the same period in 2020. The statement of Minister Dr. Poklukar logically contradicts the official statistics of SURS.

Mr. Silvester Koprivnikar reasonably and publicly asked if Minister Poklukar even knows what he is talking about: "I do not dispute your figures, but I do not believe them either. You have not provided a single piece of evidence or at least a logical explanation. But you say we have to trust the profession. Those kinds of numbers you put out require more than just believing and trusting. If you had an explanation that people could actually understand and not just believe that your estimates are correct, you would be obligated to offer it to the public. You do not have it and it's all just political propaganda?" (Koprivnikar, 2021).

Minister Poklukar's statement is based neither on serious, credible statistics nor on a theoretical, mathematical model. The minister apparently pronounced it "by rote" or he simply lied. Since people's lives are at stake, such flat statements are very inappropriate at a given time and extremely irresponsible. They diminish people's trust in science, on which the medical profession, which carries out the corona crisis in Slovenia, relies every day (Pušnik, 2021; Senica, 2021; Dolenc, 2021).

SURS statistics are the fundamental data base for evaluating vaccine performance. Daily analyses of how many new infections there are and how many infections should be prevented with vaccines are not realistic indicators of vaccine performance. The only realistic indicator of vaccine performance is reduced or increased mortality in the population. If there are fewer and fewer deaths, the vaccines are working; if there are more and more deaths, the vaccines are very likely having a negative effect. This is the sour apple of the Corona crisis that no expert has yet to bite into, but this step is inevitable. The correlation between vaccine and mortality is a fundamental parameter for scientifically accurate measurement of vaccine performance. So far, this issue has been pushed aside because it obviously does not please the "political propaganda" that vaccines are the solution.

Anyone who follows statistics in Europe has long known that vaccinated people die more often than unvaccinated people (Kirsch, 2021). According to official government statistics, 3676 people died between 42 and 45 weeks in England in 2021. Of these, 3,001 were vaccinated, 675 were unvaccinated, and of 26 people it is not known whether they were vaccinated or not. Because these painful scientific facts are absent from the political narrative about the implementation of the Covid-19 crisis, they are not talked about. The fact that, according to SURS, 754 more people have died by the tenth month of this year than in the same period last year is not mentioned because it would reflect poorly on the "vaccines are the only solution" media story.

The dilemma - what is and what is not science

The medical profession, which has always relied on science, has become its greatest adversary. Serious, responsible science has long known that vaccines will not produce positive results, that the solution lies in early outpatient treatment (EOT), especially with ivermectin and hydroxychloroquine and cocktails of agents based on science and experience (FLCCC). This solution is not in keeping with the "political narrative" of the Corona crisis and is not being addressed in public, or the profession does not want to take it seriously. Shortly before or immediately after the official start of the Corona crisis, ivermectin and hydroxychloroquine were withdrawn from availability and even legally banned in many countries (Teršek, 2022).

There is no longer a Corona Crisis but rather crisis of the common sense in the Corona politics and practice, a "new abnormality" is on the rise in which irrationalism is taking over, and a new medical doctrine is taking hold that corona vaccines are more effective than natural immunity. In this context, only "science" and "faith" are referred to, although the basis for the claims is not really scientific, but pure and gross manipulation (Van Bavel, Baicker et al., 2020). People have begun to doubt the pure intentions of the Corona Crisis practitioners and have good, even categorically indisputable reasons for doing so. People's health, and even their lives, have become a completely irrelevant matter to the decision makers and a surprisingly large portion of the profession (Cloete, 2021). In the Corona Crisis, capitalism has realized its essence, which consists in the destruction of the existing human civilization, in the genocidal depopulation for a new social order in which man is only an insignificant number, in which there is no being anymore. The most important scientists in the world (the media-savvy medical profession in Slovenia is obviously not one of them) have been lecturing and writing about it for more than a year. Despite the total censorship by the mainstream media, which follow the logic of short-term financial gain. The philosophy of the performers of the crown crisis is about taking over and playing the role of God. Constructive critics call them "conspirators and anti-vaxers," accuse them of distrust of science, and at the same time clearly and indisputably violate with indifference all the principles, rules and findings of science, medical ethics and deontology. They are whistling for a year and a half to tackle the problem of indoor vaporization, which is scientifically and empirically the only effective measure to limit aerosol-borne diseases (Keber, 2015, 2021). They are wrapped in a spiral of lies that is rapidly increasing and thickening.

Whenever such an idea was born in the history of mankind and with it the combined (pacting) practice brought devastation and suffering (Trontelj, 2002; Declaration of Helsinki; Katz, 1997; Nuremberg Code; VIZITA.SI, 2011; Code of Medical Ethics, 2016). This time will be no different. The apocalyptic philosophy of the carriers of the Corona crisis has replaced love for people with contempt and hatred, and common sense with irrationalism and the creation of a collective hysteria. The carriers of the Corona crisis are accountable to no one: they are not accountable to legal institutions, not to the profession, not to the people, and not to themselves. Conscience, morality and humanity have been eroded. It is the embodiment of the evil of artificial intelligence, which has put itself first and has no control mechanism. The devil has escaped from the bottle and will be tamed only when people begin to activate their cerebellum, i.e. their survival instinct. Will this happen in Slovenia with 10,000 deaths from vaccines, with 100,000 deaths from vaccines? Nobody knows that (Tucker, 2021; Kennedy, 2021; Tyson, Fareed, 2022; Haley, 2000; Flemming, 2021; Ridely, 2021).

2. METHODS

Mathematical analysis of Covid-19 vaccine efficacy is strong scientific evidence for immediate cessation of Covid vaccination. The mainstream media, on the other hand, addresses the public daily with claims that vaccines "save people's lives" and even, abruptly and abruptly, that unvaccinated people endanger other people, including or especially vaccinated people. How long these persistent media lie, and intimidation will continue depends on the intelligence of the people and the sincerity of the scientists and organizations involved in vaccination. By prolonging and intensifying the vaccination hysteria, people are dying needlessly. Since their introduction, bovine vaccines have done nothing to improve human health and will not save human health in the future (Bohm, 2022; Bossche, 2021).

3. RESULTS


The red light for the end of vaccination is on. Let us open our eyes and see the scientific and empirical truth. Our mathematical results are preliminary (Šorli, Žurej et al, 2022), but obvious enough that competent health institutions, and the UK health authority will get more accurate results by a detailed analysis of the fact that mass vaccination has done more harm than good.

Mathematical analysis descriptive

Or, as the extract from the article Šorli, Žurej et al, 2022; shows

Let's see corona vaccination from the perspective of mathematics. We have a set of alive people A in a given country. In this set A, we have a subset of alive people that are vaccinated AV. These people we can call red people. Vaccination has no impact on people's health.

In the period of 4 weeks, people in set A are dying. We have for every 4 weeks a subset of dead people D. As vaccination has no impact on people's health, in a set D we will have the same percentage of vaccinated people as in a set A.



We can write a following equation:

Using equation (UK HEALTH SECURITY AGENCY 2) we can calculate the number of dead vaccinated persons in England in a given 4 weeks. The number we get is an ideal number where there is no impact of the vaccination on the death rate. When 10% of the population is vaccinated in the group of dead persons 10% will be vaccinated. When 20% of the population is vaccinated in the group of dead persons 20% will be vaccinated and so on.

Now we compare the numbers of dead vaccinated persons in official statistics with the ideal number we calculate. The statistical number of dead vaccinated persons must be lower than the ideal number. In this case, vaccines are saving people's lives:

vaccinated dead < vaccinated dead ideal number (UK Health Security Agency3)</pre>

We can calculate how many persons have been saved from death with vaccination in a given 4 weeks by following equation:

In case that the number of vaccinated dead is bigger than the number of calculated dead vaccination has a negative impact on mortality rate, it takes lives, some people have died prematurely because of being vaccinated:

lost lives = vaccinated dead - vaccinated dead ideal number (UK Healt Security Agency 5)

4. DISCUSSION

The idea that vaccination against Covid-19 prevents people from dying from Covid-19 is false. Yes, people do die from Covid-19, but if they are vaccinated with the Covid vaccine, they are *de facto* more likely to die. Vaccinated people die faster than unvaccinated people (Mathieu, Rose, 2021). The science is categorically clear on this 8Facts About Covid). This has been confirmed by German scientists, among others (Steyer, Kappler, 2021). Research by Ingrid Tojersen confirms that vaccination with kovid-19 causes death in the elderly (Tojersen, 2021). Our preliminary results are in accordance with the clinical results of prof. Burghardt, statistical results of prof. dr. Rolf Steyer and dr. Gregor Kappler and statistical results of Ingrid Tojersen.

In science, we know that once clinical results overlap with statistical results, there are no big surprises. We are confident enough to call on the international scientific community to demand an immediate halt to vaccination against Covid-19 worldwide. In 2020, we had a global excess of deaths due to the official Covid-19 pandemic. In 2021, mass vaccination began around the world. In the first 11 months of 2021, 71 more people died in Slovenia than in the same period in 2020 (SURS).

How is it possible that, despite mass protection against Covid-19, we still have more deaths in 2021 than in 2020, when there was no vaccination? It is now clear that the assumption "Covid-19 vaccines prevent infections and save lives" is not at all true. Both unvaccinated and vaccinated people are equally exposed to Covid-19. The data confirm that vaccinated people die faster than unvaccinated people. Our analysis confirms that the natural immunity of unvaccinated people provides much better protection than Covid vaccines (Maragakis, Kelen, 2021; Hatchard, 2021). (Note: Increased mortality at this time may also be a statistical consequence of the slow inflow of information, due to the flu, due to untreated diseases, suicides ... No one has been monitoring this for too long. But that doesn't change the fact that official claims of allegedly increased mortality from Covid-19 disease are obvious and blatant, even transparent lies). Let us just be surprised if common sense wins out - soon? Let us hope so.
